**SUBJECT: TERMINATION OF MEMBERSHIP IN ACCORDANCE WITH THE
MEMORANDUM OF KDAOC**

This is to inform you that the Working Committee of the KDA Officers' Club (KDAOC), notified vide letter of even No: dated 16th November, 2025 have a detailed review of the *Committee Report dated 21.11.2025*, has recommended the termination of your membership pursuant to Section 3.4, Sub-Section 3.4.6 of the MEMORANDUM OF ASSOCIATION OF KDAOC.

According to the report submitted by the Working Committee, the following concerns were noted:

1. You have allegedly been involved in sharing, circulating, and promoting controversial, misleading, and negative propaganda against the objectives, aims, and interests of the KDA Officers' Club.
2. It has been stated that you have repeatedly violated the rules and regulations of the Club, including the unauthorized sharing or attempted disclosure of KDAOC's bank statements and internal information, without any lawful authority.
3. The Committee has also noted your involvement in spreading unauthentic, false, and fabricated information, including allegations relating to Club expenditures and administrative matters.
4. It has been recorded that such actions create an ambiguous and disruptive environment for the general membership of the Club, contrary to Section 3.2 of the MEMORANDUM KDAOC, which requires every member to, "*to the best of his/her ability, protect the objectives and interests of the KDAOC.*"

After considering the findings of the entire period and your response(s) to previous notices, the Committee has concluded that your conduct constitutes violations warranting disciplinary action under the MEMORANDUM OF KDAOC.


DECISION

RIGHT TO REPRESENTATION / APPEAL


